## What is a written statement of action

A joint SEND (Special Educational Needs and Disability) inspection was carried out in Shropshire Council, the Shropshire Clinical Commissioning Group (CCG) and its outseed healthcare providers, as well as schools, colleges and other educational establishments, care providers and other key stakeholders - also known as the local area in Shropshire. The final letter was published on 6 March 2006. The inspection identified a number of concerns and, as a result of these findings and in line with the 2004 Children's Regulations (Joint Area Review) 2015, the Chief Inspector determined that the local area in Shropshire CCG and The Maternity and Care Board (PACC) have worked together to develop this co-produced WSoA, which identifies measures that will be taken by all partners to ensure timely improvement, as well as providing an indication of what difference we expect these measures to make to our children and young people with SEND and their families. This will ensure that SEND is a priority for everyone and that all partners recognise the importance of send. Follow the link to see and read Shropshire Written Statement Action. Ed Potter, Shropshire council member for children's services, said: Since the inspection in January the partners have worked together to negotiate the WSoA, which has been co-produced with parents and carers. This takes into account all six priority areas identified in the inspection report as well as the ambitions of the SEND community identified under the SEND strategy. We have received feedback from Ofsted/CQC that the action plan presented has been adopted as fit for purpose and that it meets the requirements of inspectors. Shropshire Council and Shropshire CCG are committed to working together and any future developments will be supported by the principles of cooperation. Dr Julian Povey, joint chairman of Shropshire and Telford and Wrekin CCGs, said: We are aware of areas of concern and that through joint work and co-production with our partners, we need to make the necessary improvements to ensure a future in which children and young people can expect and have the same opportunities in life as others. The Shropshire Board of Caregivers (PACC) welcomed the partnership approach to WSoA. A PACC spokesman said: 'We look forward to continuing to work this way with Shropshire Council and the CCG to ensure that the parent carer's voice remains central to all activities and decision making during the implementation phase of the statement."
