[20] Project+: In 2001, CompTIA acquired the Project + Project Management Certification Program from the Gartner Group. The program, formerly called IT Project+, was updated in 2003. [32] [33] Security +: Also certified as ANSI in 2008. [17] Security+ is an entry-level vendor-neutral security certification based on network security knowledge covered by Network+ authentication. [34] It expires in three years. [20] Certifications certified before January 1, 2011 are considered lifetime good and will not expire. [21] Server+: Focuses on server-specific hardware and operating systems, IT environments, disaster recovery, and business continuity. [35] It was developed in 2001 and updates were released in 2005 and 2009. [36] Master-level authentication Advanced Security Practitioner Authentication (CASP) is authentication to follow Security+. The CompTIA Advanced Security Practitioner Certification was certified by the International Organization for Standardization (ISO) and the U.S. National Institute of Standards (ANSI) on December 13, 2011. [17] Casp exams prove that successful candidates have the technical knowledge and skills needed to conceptualize, design, and engineer security solutions in complex enterprise environments. In March 2013, the Department of Defense approved certification with approved baseline certifications for Information Assurance Technology Level III, IS Administrator Level II, and IA System Designers and Engineer Levels I and II. [46] Prior to the certification expiration, CompTIA sold its flagship A+, Network + and Security + certifications as lifetime valid. In January 2011, CompTIA changed the status of these certifications to expire every three years. Under the proposal, accredited individuals would be authorized to re-certify their exams or pay an annual maintenance fee for the Ceu (Unit of Lifelong Education) system. CompTIA has revised its guidelines so that only certificates received after January 1, 2011 must be renewed every three years. However, a certain amount of documented time associated with using authentication automatically renews the authentication. [47] Non-expiring certificates issued before 2011 are officially called Good-for-Life, and getting more updated (expirable) certifications does not replace good certificates for Life.
