It will also serve as a source and assembly point for the community as a whole. History Opened in 1927, the Capitol Theater was a major stop on the Vaudeville circuit and later Concord's premier movie house and concert hall. Over the years, however, the theater slipped into disrepute and in 1989 it was closed with \$4.2 million raised to support the newly created, nonprofit Capitol Center for the Arts, and 250 volunteers contributed more than 3,000 hours to paint and restore the Egyptian-themed work of art, the renamed theater opened in November 1995. The Chubb Theatre was named in recognition of the project's greatest benefactor, Chubb Life. The 1,304-seat theater is now equipped to present many of today's lavish Broadway shows. It has been upgraded with new heating, air conditioning, electrical and plumbing systems, wheelchair access including lift, new lobby and hallway, computer cash register system, updated backstage facilities and restored seats. The Capitol Center is also home to spotlight café, a place where the community can discover exciting work in a hip, club-style atmosphere. the event will be held in the governor's hall, the first-floor ballroom at the Capitol Center, with a general reception table and a row of seats up to 250. While the Chubb Theatre works well for great productions and high profile artists, Spotlight Café offers audiences the opportunity to experience up-and-coming artists in intimate settings. The Capitol Center's mission is to be a resource for the entire community. Accordingly, the center presented a broad mix of high-quality events, including Broadway shows, dance performances, school-time shows and business conferences and seminars. Today, the Capitol Center for the Arts is the largest and most successful performing arts center in New Hampshire and has helped position Concord as a cultural destination. Its richly varied programming attracts a diverse audience. Broadway, ballet and country & England to attend performances at the Capitol Center. Capitol Center. education programs attract about 14,000 schoolchildren a year from across New Hampshire. Educators and parents certify performances in school series, teacher workshops, information activities and symposia on topics such as racism and intolerance. Working with local and state educators, the Capitol Center successfully linked the school series to nationwide curriculum goals, making programming even more valuable. Tickets and rental rates are still affordable, subsidizing nonprofits and schoolchildren. Each year, approximately \$10,000 in tickets are donated to organizations serving disadvantaged children and families, including the Concord Boys and Girls Club, Concord Housing Authority, Children's and Family Services, Friends Program, Merrimack Valley Day Care, Children's Place and Senior Companion Program. The Capitol Center also houses the governor's hall, a full-service function room that can accommodate up to 350 guests, and the adjacent Kimball House, a Victorian mansion featuring a stately, formal dining room, library, salon and meeting room. tickets in person at the Capitol Center checkout during normal business hours.
