Many parents pay thousands of dollars each year to send their children to private schools - especially those who live in areas where public schools are of poor quality. However, this does not mean that parents who live in good school districts spend less overall. This means that parents who want the best possible education for their children have a difficult choice: to pay directly for a private school or indirectly pay for a home near a good public school. To understand what is best, they need to know exactly how these two costs compare and what options they have to maintain costs. The cost of a private school According to data from the National Center for Education Statistics (NCES), about 4.5 million American children were enrolled in private schools in 2011-2012. More than 80% of these students were in schools of some kind of religious affiliation. Some 43% were in Catholic schools and another 37% went to schools identified as a general Christian, Jewish or specific Christian denomination. Some 68% of all private schools have a religious orientation and 32% are not religious. On average, the cost of private school tuition for the 2011-2012 school year was \$10,740 per child, according to NCES. It's a big burden for the middle class. In 2014, the national average household income in the United States was \$53,657, according to the U.S. Census Bureau. This means that a family making median income will have to spend about 20% of their income to send only one child to a private school and 40% for two children. However, the cost of training varies greatly depending on the type of school. The average tuition fee is \$6,890 a year for Catholic schools, \$8,690 for other religious schools, and \$21,510 for non-government schools. So a middle-income family will pay less than 13% of their income to send a child to a Catholic school, but over 40% for a non-religious school. The cost of public school The cost of a private school is easy to identify - only a fixed number of dollars per year. Calculating the cost of public school is much more complicated. You need to know which neighborhoods parents choose for their schools, how much it costs to live in these neighborhoods, and how that price compares to the cost of living in other, nearby neighborhoods. A good place to start has a niche, a website that values and compares American school districts based on factors such as student ratings, grades, health and safety assessments, and feedback from parents and students. Each year, the niche lists 10 school districts that rate it as the best in America. For 2016, the number one school district on the ish list is the Tredyffrin-Easttown School District. Centered in Tredyffrin CityShip, Pennsylvania - a suburb of Philadelphia - this neighborhood earns A-plus ratings for its academic achievements, teachers, extracurricular activities, and more. According to Trulia, the median price for homes in this area is \$532,500. This is due to a monthly mortgage worth about \$2,610, based on a 30-year loan, a 20% down payment and interest of 4%. For a buyer who can only afford a 10% advance payment, the monthly payment jumps to \$3,072. In nearby Paoli, by contrast, Trulia says the median starting price is just \$287,000 or \$1,407 a month. That's a difference of \$14,436 a year - about 34% more than the average cost of private school tuition for a child. So a family with one child will spend less, living in Paoli and sending the child to a private school. However, a family with two or more children will spend less living in Tredyffrin, where the extra money paid for housing will cover school costs for all children. A 2014 article on money school spending reached a similar conclusion. Conversely, making smart decisions about housing can make life in a large school district an affordable choice, even with just one child. Private school options One way to make a private school more affordable is to choose a school with lower education. As noted above, religious schools - especially Catholics - are much more accessible than non-governmental private schools. According to NCES data, a family can send two children to a Catholic school for an average price of \$13,780 a year. That's slightly less than the extra \$14,436 a year it costs to live in Trediefrin rather than Paoli. Another option for a private school is Montessori School. These schools use an educational approach that focuses on children learning at their own pace, using all five senses. Most Montessori programs are for younger children, but some stretch into early adolescence. According to the From North American Montessori Teachers' Association, the cost of a year at montessori school varies widely, but the average cost for elementary school students is about \$8,600. You can enter your country and region in the site's expanded search engine, and then select your criteria for school quality, price, and other features that are important to you, such as crime or walking. However, to use this feature, you need to subscribe to the site, which costs \$40 per month, \$90 per quarter, or \$192 per year. Another way to afford a home in a high-end neighborhood is to choose to live in a smaller house. In the town of Trediefrin, PA, for example, Zillow lists three-bedroom homes for just \$390,000. A mortgage on a house like this will come in at about \$1,912 a month - savings of \$698 a month, or \$8,376 a year, compared to the average house price. Final Word When choosing a place to live, the school district is not the only factor to consider. For starters, you want to find a home that's close to your workplace so you don't have to face a long commute every day — even one close enough to allow you to walk or cycle to work.
