Traffic, Misdemeanor and Felony cases consist of 2 digits for the year, a 6 digit sequence number, a 2 letter Division identifier, 2 digit location and a 1 or 2 letter Companion Designator. How to buy electronic certified court documents online: conduct a case search to locate the case. On the Search Results page, select the capital number to display the capitalization details. Select the Red Buy Certified Copies button online. Accept the terms of service to start the purchase process. Select all the documents you want to buy, and then click the Green Buy Selected Documents button to start the check-out process. Upon completion of the purchase, you will receive an email from eCertify@browardclerk.org with links to the certified documents. The time it takes to deliver the electronically certified document(s) depends on your email server. It's normal to have to wait a few minutes before receiving an email to your inbox. Civil Traffic InfractionsE civil traffic violation is a non-criminal offense that can usually be removed by paying a civil penalty or election to attend a defensive driving course. A court hearing is not required, except in cases where the offence involves an accident involving serious bodily injury, a fatality or certain other offences. Payment must be made within 30 days of the date on which the ticket was issued. A delinquency fee is added and your driver's license is suspended if a citation is not paid within 30 days. Unpaid citations are transferred to a collection agency after 120 days and additional costs are assessed. Payment can be made by post, via the internet, via Western Union, at any Amscot location, or in person at any of our offices in Titusville, Merritt Island, Melbourne, Viera or Palm Bay. Driver Improvement SchoolThe ability to go to school does not apply to all traffic violations. If you hold a CDL driving licence, you are not eligible for the choice of driving school. If you are charged with exceeding the speed limit by 30mph or more, you are not eligible to choose driving school - a mandatory court appearance is required. Successful completion of the driver improvement school will keep violation points from being entered on a driver record. You must complete the school and provide proof of completion to the registry within 90 days of the violation date. The school's enrollment fees will be charged in addition to the assessment for the violation. There are independent traffic schools that serve this area listed in the phone book yellow pages under Driving Instruction and Traffic Schools. Others appear in the Useful Links section. School requirements: You don't have a commercial driver's license. You don't drive a company car. You don't choose school more than once in 12 months. You only choose school 5 times in your life. Parking tickets must be paid within 10 days of the date the ticket was issued. Criminal Traffic OffensesA Criminal Traffic Offense is an offense that can subject a suspect, upon conviction, imprisonment.
