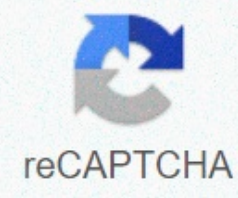

**Ashtabula county courthouse marriage license**

unique aspect of the succession court is that the probate judge is an official of the court of its own motion, and therefore the Court performs all its duties as its own bailiff (indexing, application, docking, etc.). The history of the probate court term Probate comes from the Latin word Probare, which means to prove. Cases in early English religious courts were proved before a church judge. Early U.S. probate courts are tracked back to those English religious courts that were competent for the decline of will and wealth management. The first trial in the United States was in Massachusetts in 1784. Similar courts have been established in other countries under the name Surrogate, Orphan Courts or Ordinary Court. The Northwest Or ordading of 1787 provided for the first probate judge and court in Ohio. Under Ohio's first constitution, written in 1802, the Court of Appeals had exclusive jurisdiction in succession cases. The 1851 Constitution removed succession cases from common pleas court and created a separate probate court in each county. Subsequent amendments to the Constitution in 1912, 1951, 1968 and 1973 and amendments to the codified law in 1932 and 1976 made the Court of Succession what it is today; separate division of the Court of Common Pleas. Probate Court Mission Statement The mission of ashtabula County Court of Common Pleas, Probate Division, is to provide quick and fair solutions to legal issues, disputes and other legal issues for all who appear before the Court, and for all whom the Court has a duty to protect. The Court will serve the citizens of the community with dedication, professionalism and integrity and will seek: accurate and effective record-keeping; provide the court and its records with timely access; and carry out their duties and accordance with Ohio law. Court budget Funds required for the day-to-day operation of the Probate Court are provided through the Ashtabula County General Fund allocated by county commissioners. The court returns a significant amount of money to the General Fund by charging court costs and fees that are established by the Ohio legislature. Jurisdiction Jurisdiction of the Probate Court is determined by the revised Ohio Code. The Code imposes many different obligations on the court. Below is a brief outline and description of some of these responsibilities. Property management The greatest responsibility of the court is related to the supervision of the assets of fraudsters. The annual load of the Court's property case is approximately 750 properties. The court oversees the management of the estate by appointing a trustee of the estate (executor or administrator) if necessary, who must collect the assets of the fraudster, pay all legal obligations and debts of the fraudster and allocate the remaining assets to those who are entitled to inheritance. Most full properties are closed within nine months. A properly drawn and executed will is beneficial and will allow for more efficient administration of assets. It is recommended to consult a lawyer in order to prepare the will. Guardianship Another main duty of the Court of Succession is to protect those who cannot protect themselves, such as mentally incompetent adults and minors. They may not be able to protect their financial affairs and/or their person. In order to protect the interests of those persons, the Court shall appoint a guardian who shall be accountable to the General Court for the management of the assets and the person of the district. The annual burden of the court's guardianship case is about 65 cases. Trusts Probate Court oversees many types of trusts, including willful trusts, which are established by will will, inter vivos trusts that are established by a person over the course of their lives, wrongful death trusts that are established by the Probate Court for the protection of minors who receive funds from the wrongful death of a relative, and supplementary trust needs to ensure a higher quality of life for people with disabilities. Mental illness and mental retardation The Probate Court oversees the involuntary civic involvement of persons who are allegedly mentally ill or mentally handicapped. The Court has hearings to determine whether a person is hospitalised and to determine the length and place of treatment. All persons involved have legal representation throughout the process. Each year, the court of succession conducts about 10-15 hearings on commitments. These proceedings and records are confidential under legal law. Adoptions All adoptions made in Ashtabula County must be finalized by the Probate Court. wishing to accept are obliged to submit to a personal investigation at home in order to insure their usefulness as adoptive parents. About 50 adoptions are submitted each year. Hearings and records are confidential under legal law. Birth certificates The Probate Court has the right to correct birth certificates and issue delayed birth certificates for people born in Ohio. Birth certificates for people born in Ashtabula County as well as death certificates of people who died in Ashtabula County between 1867 and 1908 can be found in Ashtabula County Probate Court. After 1908, people born in Conneaut or Ashtabula, birth certificate are found in their respective municipal health departments. People born in another area of the county, birth certificate are located in the Ashtabula County Health Department. Similarly, after 1908, people who died in Conneaut or Ashtabula, the death certificate are located in their respective municipal health departments; and people forking out in another area of the county, these death certificates are located in the Ashtabula County Health Department. Changing the name of an Ashtabula County resident who wants to legally change his name must apply in Ashtabula County Probate Court. The court hears name changes for both adults and minors. The person applying for a change of name must have been resident in Ashtabula County for at least one year prior to the application. All cases are set for questioning and publication is required in all cases. About 50 name changes are processed annually in the Court of Succession. Marriage licenses: 8 a.m. to 4 p.m. (440) 576-3453 Approximately 650 marriage licenses are issued annually by the Ashtabula County Probate Court to couples who wish to be married in Ohio. The cost of a marriage license is \$45.00. Applicants are encouraged to apply for marriage licenses through a virtual meeting. Marriage licenses are issued in person in the Court of Succession on Tuesday, Thursday and Friday, ONLY. General requirements Ohio residents must obtain a license in the county where any of the applicants live. (At least one of the applicants must be a resident of ashtabula county marriage licenses to be issued by Ashtabula County Probate Court.) The license is valid anywhere in Ohio for 60 days from the date of issue. Out-of-state wedding residents in Ohio must obtain a license in the county where the ceremony will take place. Any applicant under the age of 18 must first apply for permission to marry a minor in Ashtabula County Juvenile Court. After obtaining the consent of the Juvenile Court, the license can be issued only after 14 days from the final decision of the Juvenile Court. The probate court will not issue a licence or accept 14 days ago. A copy of the order must be delivered before the application is accepted. Both applicants cannot be closer relatives than the other cousin and have no spouse. Applicants must present an identity card, such as a driver's license or a state-issued id, passport or birth certificate. Applicants must complete the application for a marriage license and provide the following information: social security number, current address, information on previous marriages, including divorce case numbers, dates and names of previous spouses, city of birth and names of parents. Virtual meeting requirements To obtain a marriage license, both applicants must be present at the virtual meeting. Candidates must have a valid email address, printer, and a working video camera, such as a laptop or smart device. Applicants must present a valid photo ID during a virtual meeting. Applicants must provide a credit or debit card to pay the \$45 marriage license fee, or send the order before the meeting. Applicants must return the original signed summary of the officiant's return in order for the marriage to be recorded. Requirements for in-person applications Applicants must complete the application for a marriage license and provide all the information required above. Exact cash, money order or credit/debit cards are accepted for a marriage license fee of \$45. There is a \$2.95 convenience fee for all credit/debit transactions. Licenses will only be issued on Tuesdays, Thursdays and Fridays. Both applicants must be present. Applicants must comply with all sent requirements for entry to the court of succession.
