## Flagler county clerk of court traffic tickets

November 5, 2020 – The Flagler County Clerk's Office of the Circuit Court & Comptroller is ready to grant a discount of at least 40 percent for two weeks to those who have overdue tickets or fines and fees. We offer this program to help our residents who have tickets, fines and fees that are in the collection, said Court Clerk and Comptroller Tom Bexley. This may allow some to restore their suspended driving privileges once the outstanding fines and late fees have been paid. This special program, titled Operation Green Light, is only available for two weeks, from November 9-20. While late fees are not waived, anyone who is subject to a fine and a fee will be spared the cost of collection surcharges within this period. Those fees can be substantial, Bexley said. It can be as much as 80 dollars on a 200-dollar speed ticket if you drive 10 to 15 km/h over the speed limit. Operation Green Light is a go between 8:30 .m. and 4:30 p.m. .m. Monday through Friday (noon to lunch.m Closed for lunch) at the first floor Central Receiving Office, Kim C. Hammond Justice Center, 1769 E. Moody Boulevard, Building 1, Bunnell. The office will remain open until 6.m p. on Tuesday, November 10, and until 6 p.m. on Thursday, November 19, to accommodate those who fail to make it during normal business hours. The office will be closed on Veterans Day, Wednesday, November 11. Payments are accepted in cash, cheque, payment order or credit card. Third-party checks are not accepted. Telephone and online payments are also accepted. Suspended driving licences cannot be restored for drivers who have overdue tickets in another county, an expired driver's license, or other offenses that would make them ineligible. Florida law gives you three options regarding your quote. You must exercise one of them for the next 30 days or be subject to a late fee and possible other actions including the suspension of your driving licence. Even if you feel you deserve the ticket, you can choose the traffic school to keep it away from your record, avoid the points and prevent the violation from increasing your insurance rates. In each county there is a clerk of the district court, who is selected in accordance with Article VIII, Section 1. According to Florida statutes, a civil violation traffic ticket is a non-criminal violation that can usually be disposed of by paying the civil penalty (fine) or choosing to attend the traffic school. These violations are usually divided into three categories: moving, non-moving, or pedestrian. A mobile violation usually evaluates points with the driver's license, while non-moving violations do not. Examples of movable violations are negligent driving, do not give in to a stop sign, etc. Examples of non-movable violations are not seat belts, improper parking, etc.; and pedestrian injuries are jaywalking. When does my traffic quote have to be paid? Payment of a traffic quote must be received by the Clerk's Office within thirty (30) calendar days after the date of issue. Remember that if you send your payment, it must be received by the 30th day in the clerk's office. Payments received after the 30th day are considered criminal and are subject to a late fee and/or suspension of your driving licence. Where can I pay for my quote? If your traffic quote has been issued in Flagler County, you have many options to pay: by post, in person, by phone, or online. How do I pay for my quote online? You can now pay all court costs, fines and fees and opt for a course to improve the driver online at [pay.flaglerclerk.com](http://pay.flaglerclerk.com). Please note that online payments under Florida Statute 501.0117 are charged a fee for a convenience fee. How do I pay for my quote on the phone? You can now pay all court costs, fines and fees, as well as choose a driver improvement course by calling (855) 895-8060. Please note that there is a charge for telephone payments under Florida Statute 501.0117. How do I pay for my quote at a participating retail location? You will be able to pay all court costs, fines and fees, as well as choose a driver improvement course online at [pay.flaglerclerk.com](http://pay.flaglerclerk.com). Select the Cash Payment option, receive a PayCode and bring the PayCode to the retail store you selected. Please note that a convenience fee for cash payments in retail according to Statute 501.0117. Important instructions for online and telephone payments: The user can choose to attend a driving school by using this service. The user CAN use these for the following quotes or requirements: A mandatory court appearance proof of vehicle registration required proof of insurance required proof of driving license required faulty equipment During quotes are usually for payment within 2 working days, it can be issued anywhere from 3 to 14 working days from the date of their citation until it is available for payment. Between 8.30 .m.m. and 4:30 p.m..m, Monday through Friday at the Central Receiving Window on the first floor of the Kim C. Hammond Justice Center (personal checks, checkouts, cash orders, cash or credit cards: Visa, MasterCard, Discover and American Express accepted). Please note that credit card payments in accordance with Florida Statute 501.0117 are subject to a comfort charge. If my quote was issued outside Flagler County, can I pay the fine in Flagler County? No. The Flagler County clerk can accept payment for traffic notices issued only in Flagler County. If your quote was issued outside Flagler County, contact the county clerk. All quotes issued in Flagler County must be paid for in Flagler County. A list of florida Clerks of Courts websites can be found on our links page. What action can I take when I receive a ticket notification and I don't think it's mine? If you have reason to believe that you are not the person quoted for a quote, you can do the following: If the ticket is a civil violation, you can request a court hearing. You should also submit an affidavit to the clerk's office when requesting the hearing. If it has been more than 30 days since the ticket was issued, you must submit an application for the suspension of the driver's license and an affidavit of identity. If a case is a criminal traffic ticket, you will be informed of a hearing date. At the hearing, you should inform the court that you are not the person cited for the citation. In both cases, it is advisable to personally seek the assistance of a deputy clerk at each of the clerk's offices. What are the options when I pay for my quote? If you received a traffic quote in Flagler County, you have thirty (30) calendar days from the date the ticket was issued to select one of the following three (3) options to redeem the ticket. Option 1: Pay The Citation Payment for a Traffic Infraction citation is due within 30 calendar days after the release date. Your case will be fulfilled upon payment, that the will be entered in your ticket as a conviction. Points will be evaluated where appropriate. Please note: If you choose this option, you may not choose the school option later or request a court date. Option 2: Plead Not Guilty If you choose Option 2 to plead not guilty, you can go to the Kim C. Hammond Justice Center, 1769 East Moody Blvd., Bldg. #1, Bunnell, FL, within thirty (30) calendar days of receiving the Central Cashier ticket at the Kim C. Hammond Justice Center, 1769 East Moody Blvd., Bldg. #1, Bunnell, FL, and submit your request for a written hearing to the clerk. You will be informed in writing of your court date. Or you can fill out a court election form and send it to the clerk's office, where a court date is requested. You will be informed of your court date. No court dates are set by telephone. If you cannot appear in person for your court date, you must submit an affidavit to the defense instead of your personal appearance. NO CONTINUANCES WILL BE ALLOWED. Option 3: Select Driver Improvement School If you choose Option 3 to attend driving school, you must pay the fine and complete an affidavit to choose the school and submit it to the clerk's office within thirty (30) calendar days of receipt of the ticket. You will receive an additional ninety (90) days to attend a Driver Improvement School in the state of Florida, and no points will be scored based on your driver's license. If you do not attend Driver Improvement School, this will result in a report on the suspension of your license and the assessment of late fees. You must send a certificate of completion to the clerk's office within 90 days or send it by e-mail. Who can choose to attend a driving school? A person charged with a traffic violation may be entitled to attend a driving school. A person charged with a violation of driving licences, vehicle registration, proof of insurance, accidents or unattended child in a vehicle is not entitled. Persons who hold a CDL driving licence are not entitled to attend a school to improve the driver. What are the benefits of leaving school for drivers? There are two advantages. First, no points are scored against your driver's license. Two, the visit to the driver improvement school to satisfy the violation, is entered in your driver history record as a withheld rating. How much does it cost to attend school? School costs vary by school. You must pay the civil penalty for the offence plus the cost of driver improvement school. How do I start You can visit the Flagler County Clerk's Office to make your choice, or your choice can be made by post in the Elect Traffic School form. You can also make an online or phone payment and choose the school using these methods. Send your quote, personal check (if drawn on a Florida institution), draw), Cheque or money order to Clerk of the Courts, The Kim C. Hammond Justice Center, 1769 East Moody Blvd, Building 1, Bunnell, FL 32110. Your payment must be accompanied by a signed and notarized affidavit and must be received by the Central Fund within thirty (30) calendar days of receipt of the ticket. You must register, participate in an approved school course and complete an approved school course within 90 calendar days from the date you signed the affidavit. You must pay for the course at the time of enrolling at the school. How do I choose a school? The Department of Highway Safety and Motor Vehicle's (DHSMV) lists licensed ride-hailing schools on its website. . You can also check the yellow pages in your local phone book. What steps do I take after completing the Driver Improvement School? You must provide the Flagler County Clerk's Office with proof of completion of the ride school within 90 calendar days of the date you selected the option. What happens if I don't attend the driver improvement school I chose? If you choose to attend school, you must complete the course and submit your certificate to Flagler County Clerk's Office within 90 calendar days of your choice. If you do not turn on your school certificate within this period, additional late fees will be assessed, your driving licence may be suspended and points will be assessed based on your driving licence. How often can I choose to attend a driving school? You can choose to attend school to pay for a legitimate traffic violation once in a 12-month period, but not more than five (5) times in your life. If you decide to participate but do not meet the requirements, the choice will still count towards the allowed 5. How many points can be scored based on my driving licence? In the event of payment of a civil infringement or a guilty verdict by the court in an infringement or criminal proceedings, the following points will be assessed for your license: Non-movable violation – 0 points Movable infringement (non-speed ingescent, no accident) – 3 points Moving Violation (not accelerating, resulting in an accident) – 4 points speed less than 15 miles above the speed limit – 3 points speed 15 miles or more over the speed limit - 4 points speed leading to an accident – 6 points Passing a stopped school bus - 4 points Reckless Driving - 4 points Leaving the accident site with damage - 6 points Why was my case to a collection agency One case could be in debt collection agency status for the following reason: one case has been due for more than 60 days for non-payment of fines and/or costs. What are the procedures for obtaining a reduced fine with evidence? IMPROPER OR FAULTY EQUIPMENT In the event of injury to improper or defective equipment, if the person who rectification of the defect and recovering proof of such timely repair by an affidavit of compliance by the law enforcement agency within 30 days of the date on which the traffic statement was issued, and pays 4 dollars to the law enforcement agency, thereby providing the affidavit of compliance, then on presentation of the affidavit by the defendant to the clerk within the 30-day period under F.S. 318.14(4) the fine must be reduced to USD 96.00. DRIVER'S LICENSE NOT CARRIED, NO PROOF OF INSURANCE, FAIL TO DISPLAY REGISTRATION To be discharged under one of the above fees, you must provide documentation proving that your license was valid, your insurance policy was valid, or your vehicle registration was up-to-date at the time of receipt of your quote. The documents must be made available to the clerk's office within 30 days. You will have to pay a redundancy fee of USD 10.00. Where can I get a driving log history? Prints of a three-year ticket are available from the clerk's office. The records are generated from the Department of Highway and Motor Vehicles database. The cost of printing the driving history is USD 14.25 for the first page of the record, plus USD 1.00 for each additional page. Records can be purchased at Central Cashiering at the Kim C. Hammond Justice Center, 1769 E. Moody Blvd, Building 1, Bunnell, FL 32110. Who can I contact for more information about my road user, my school or court date?
