So what are some things that inspectors will erode? If the check engine is light on or not operated, the vehicle inspection Backwards will fail, passenger side view, and driver sideview mirrors should not be cracked, and if they are, they should be replaced with new or used mirrors. If the backwards are cracked on the driver's side, and the crack is large, it needs to be replaced. This could be an obvious safety hazard if not properly restored. All exterior lights, including headlights, taillights and turn signals, must be fully operational. If a bulb is blown out, it should be replaced.
