Carawan believes that opposition to religious freedom in this country is so strong and well organized that many times the average citizen feels powerless to fight it. CPCF is working to bring our leaders together nationally to form a prayer caucus in every state, he says confidently, So far we have been successful in 12 states, and there are more that will soon be added to the list. People need to know that we can successfully and decisively defeat these forces that are understecing our nation's religious and moral base. CPCF is committed to this effort for as long as necessary. Lea Carawan, executive director of the Congressional Prayer Caucus Foundation The CPCF has five main objectives in its stated mission: to promote prayer and preserve God's lasting place in the public square; Proactively protect religious freedom; Energize and mobilize government leaders and citizens to uphold Judeo-Christian principles; Provide and network leaders who desadse morality and religious expression in all aspects of society; and communicate the constitutional truths that establish the religious freedom of the United States. Summer Ingram is the cpcf's national prayer director and emphasizes one of the Foundation's strongest messages. There is always hope in America, he says with conviction, We have many good elected officials in our nation who need our support and encouragement at all levels, from local city hall, to state legislatures, and all the way to Washington, D.C. Many are already affirming their strong belief in God and the power of prayer, and there are many more to follow. Many people are familiar with the Congressional Prayer Caucus, especially on Capitol Hill in Washington, D.C. The bipartisan Congressional Prayer Caucus was founded in 2005 by Chesapeake Congressman J. Randy Forbes and is co-chaired by Forbes and Rep. Mike McIntyre (D-NC). It is a registered caucus in Congress, subject to the rules and regulations of any other caucuses such as the Black Caucus or the Hispanic Caucus. Only elected officials can be part of the caucus. Both the Congressional Prayer Caucus and the Congressional Prayer Caucus Foundation believe in the power of prayer for our nation and its leaders and citizens. The two groups, however, are very different. The CPCF is a private nonprofit organization 501(c)3 and receives no government funds. Membership is open to everyone. In CPCF we never get involved in partisan politics nor do we ever campaign for any candidate, Carawan explains emphatically, However, we want to have a prayer chain that reaches from every state legislature to every home. Couple that with knowledge of the issues relating to threats to religious freedom, and we feel that we can return America to the very basis of the Judeo-Christian principles upon which it was founded. The Internet has become a valuable ally for the CPCF and the foundation maintains its own full website in www.CPCFoundation.com It is filled with all the information necessary for an individual to be aware of the Foundation and the challenges to religious freedom it faces. First time visitors will find the site easy to navigate with many levels of support. The site also provides detailed content about news, programs, and CPCF resources. There is a call-to-action section that gives stakeholders a number of specific ways to get involved. The CPCF also works hand in hand with a number of organizations that are fighting the good fight against religious bigotry, including The Christians and Jews Scholarship, Judicial Guard, and the American Center for Law and Justice (ACLJ). An interested citizen will find the website with an abundance of informative articles and ways to get involved. There are also a number of vital links to other sites for prayer, education and action that are just a click away. Our Board is definitely nonpartisan, carawan says proudly, We have principled individuals from the two major parties who support our efforts. The CPCF has developed specific guidelines and procedures for forming and establishing a caucus in each state. Both the Summer Ingram and I are willing to help and encourage any elected official who is willing to return his state to the traditional values and religious freedom that our ancestors sacrificed to achieve, Carawan promises. There are many ways to help and we need to involve everyone. As the philosopher Edmund Burke pointed out: The only thing necessary for evil to succeed is for good men to do nothing. (Washington, D.C. - November 7, 2012) - Winners of yesterday's U.S. House races are being asked by non-religious Americans to keep their distance from the Congressional Prayer Caucus. In a letter sent today by the American Humanist Association (AHA) to all elected members of the U.S. House of Representatives, the AHA is urging them not to join the Congressional Prayer Caucus and actively work to secure the separation wall between church and state is reinforced and maintained.
