The protected permanent remote alcohol monitor, or SCRAM, read the content of the person wearing it every 30 minutes and shall take into account those readings of the agencies' supervisory authorities. SCRAM is used not only by the justice system, but has also been used with some success by alcohol treatment providers to monitor patients' alcohol consumption. SCRAM is used to help patients maintain compliance with abstinence-based programs and identify patients who need further intervention. The technology has advanced significantly since SCRAM first began offering alcohol monitoring agencies in 1997. The device that tests alcohol consumption through the skin (transdermal testing) is called SCRAM CAM (continuous alcohol monitoring). The device is attached around the offender's the test results to the base unit located in the offender's home. Initially, the base unit communicates the test results to the monitoring agency via the perpetrator's telephone line. Now the main module can use a mobile phone or internet connections. If the perpetrator is sentenced to a home stay or a curfew is set, SCRAM CAM may also monitor compliance. The device eliminates the ability of the offender to skip a test or drink around the test schedules. The remote handheld device

photographs the face as they blow into the machine, and uses facial recognition software to make sure the person doing it is the person under control. The remote control also contains GPS technology that will record the GPS coordinates of the machine every time it conducts a test. If the perpetrator misses a scheduled test, the machine records the GPS location during the missed test. In the first years of its use, SCRAM devices had some limitations and problems. Some of these problems include: Too sensitive and giving false positives can be remedied without giving a signallt could not detect some low-level drinking events can not account for false warnings of malicious interference These problems are noted in a series of alcohol monitoring devices funded by the National Highway Traffic Safety Administration (NHTSA). The study was conducted by monitoring programs for drunk drivers and other offenders involved in alcohol in several states. One of the problems reported with alcohol monitoring devices was the reluctance of probation officers and clerks to participate in the program because they would work. In the 8th District of New York, they found that if they persuaded the doubting agents to carry the devices and themselves, they soon become defenders of the program. Another NHTSA-funded study looked at the use of SCRAM and recidivism among control of alcohol. It found that the device could reduce the need for testing or other forensic officers to conduct home surveillance, leading to cost reductions. The study also reported that offenders who remained abstaining while going through alcohol treatment programs had better outcomes than those who were not monitored and did not abstain.
