Discover more of the East Bay School District retreated from personal learning on Tuesday, citing the overwhelming increase in COVID-19 cases. It's a controversial move for the San Ramon Valley Unified School District and its 32,000 students. Many of our staff have contacted me directly and I'm sure they don't feel safe at the moment, said Supervisor Dr. John Malloy. Parental surveys showed a large and growing majority supporting distance learning. He says that science clearly says to continue learning remotely at least until Contra Costa County moves from the purple layer to the red. Emotional comments from a teacher opposed to the instructions on campus saying: What constitutes putting the lives of our educational community at greater risk at the height of this epidemic? With all of our mini safety protocols in place of life that we are willing to sacrifice to achieve it? Parents in favor of personal learning had their side read to the school board, and most said the lack of personal interaction causes students to drop scores, until some lead to suicidal thoughts. I am confident that the personal model will provide a safe and successful learning platform that meets academic, social and welfare needs in the new year, Malloy said. The final decision is that there will be no personal education for the region's 32,000 students on Jan. 5. Malloy knows that this is not the end of this emotional affair. Requests for permit changes from all school sites It is routed through the county's queue process by sending an email SCattarusa@srvusd.net will continue to accept and process queue requests until Tuesday, November 24, 2020. Between Tuesday, November 24, 2020 and Tuesday, January 5, 2021, we will continue to accept requests for change, but will not be processed until after January 5, 2021. Between Tuesday 11/24/20 and Tuesday 1/5/21, we will build timetables and the information we use to do that work must remain constant. Once you build schedules and assign all students either remotely or hybridly in person for spring 2021, we will begin to process any change requests received after Tuesday, 11/24/20. We will email the form to both primary and secondary email contacts listed in the campus indefinite profile. Sending ads takes time. Ads will be filled with student-specific information, so you will need to send them in batches, so we ask for your patience. It takes some time to get the forms for all families, but they will all be sent in 11/6. In families where parents live separately, the first connection on the campus will be the model we accept. Please contact Dirk with any problems/concerns. Decisionmaking assistance: Website and city hall forums during Advertising Week (November 9-13), managers will support their communities through this process. Please search for information from your school/principal with details on how to do this. In summary, we fully understand that this decision is very important and difficult. We want to provide as much support as possible to help your decision. Our commitment is to provide an effective distance learning program. We are also committed to providing each student with the academic programming they started in August. We will follow all public health requirements. For those who choose the hybrid option, we will return to school full-time when the requirements allow physical remoteness. For those who choose remotely, you choose this option for the rest of the year. We hope that we can accommodate a change in your ad on the road, and we will create a waiting list; however, we cannot promise that we can accommodate this demand.
