industry to phase out the use of certain antibiotics for enhanced food production. Antibiotics are added to animals to help them gain weight more quickly or gain less food. Since all uses of antimicrobials are both and animals, to contribute to the development of antimicrobial resistance, it is important to use these medicinal products only when medically necessary. Governments all over the world consider antimicrobial bacteria to be a major threat to public health. Diseases caused by drug-resistant strains of bacteria are more likely to be fatal if the medicines used to treat them become less effective. The FDA is working to address the use of medically important antibiotics in food-producing animals, for example to increase growth or improve feed efficiency. These drugs are considered important because they are also used to treat human diseases and may not work if the bacteria they target become resistant to the effects of the drugs. We need to be selective about the drug we use in animals and when we use them, says William Flynn, DVM, MS, deputy director of research policy at the FDA's Center for Veterinary Medicine (CVM). Antimicrobial resistance may not be completely preventable, but we must do everything we can to slow it down. The FDA will issue a final guidance document explaining how animal pharmaceutical companies can work with the Agency to voluntarily eliminate growth guality and feed efficacy readings from the approved uses of these medically important antimicrobials and to move the therapeutic uses of these products from over-the-counter (OTC) to marketability requiring veterinary supervision. Where producers make these changes on a voluntary basis, the products affected may be used only in food-producing animals at the behest of a licensed veterinarian or on prescription for the treatment, prevention or control of the disease. This action promotes the rational use of important antimicrobials that protect public health and at the same time ensures that sick and at-risk animals receive the treatment they need, says CVM Director Bernadette Dunham, DVM, Ph.D. We understand that these steps represent changes for veterinarians and livestock farmers, and we have been working to make this transition as smooth as possible. The drug primarily Feed Flynn explains that all the drugs that this plan affects are antibacterial products. They have long been approved for production (e.g. to improve growth), as well as for the treatment, control or prevention of animal diseases.
