Use cassette tapes to secure all wires and cords. Ask the judge's staff if the judge has a preference or pet peeves. Maybe the judge has local rules for tech in court? If you've reached frequent trial, you likely have your own story of tech attempts that didn't work. That could be an entire post of itself. Mostly, my best advice to you is that, whatever can go wrong, will go wrong.
