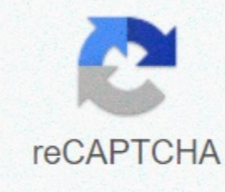

A favorite soul must not be neutral unless its deity is neutral. Hit the Dice: d8 Class Skills Favorite skills of the soul class are Craft (Int), Diplomacy (Cha), Fly (Dex), Heal (Wis), Knowledge (arcana) (Int), Profession (Wis), Sense Motive (Wis), and Spellcraft (Int). Skill rating to level: 2 + Modifier Int. Features of the class All following are class features of the favorite soul. Weapon and armor knowledge: Favored souls are prowess with all simple weapons, light armor, medium armor and shields (except tower shields). The favorite soul is also adept at his deity's favorite weapon. Although the favorite soul is not adept at heavy armor, wearing it does not interfere with her charms. Aura (Ex): The favorite soul of a chaotic, evil, good, or lawful deity has a particularly powerful aura corresponding to the alignment of the deity (see revealing an evil spell for details). Divine connection: Divine magic is intuitive for a favorite soul, not a matter of careful prayer. This intuitive nature leads to a looser interpretation of faith and dop. Every favorite soul must choose a deity. Unlike spiritual souls, popular souls cannot devote themselves to the cause or source of divine power instead of the deity. Favorite souls cast divine spells through innate association with their deity, rather than through laborious training and prayer. A favorite soul doesn't have to prepare his magic in advance. She can cast any spell she knows at any time, provided she has not yet used her spells per day for this level of magic. She doesn't have to decide in advance which spells she'll cast. Spells: The favorite soul casts divine spells that are drawn from the list of spiritual spells. She can send down any spell she knows without preparing him for the front. To cast a spell, a favorite soul must have a charisma score equal to at least + magic level. Difficulty class for saving throw against favored soul spell is 10+ level spell + favored soul wisdom modifier. Like other spellcasters, favored souls can cast only a certain number of spells of each level of magic per day. Her basic daily allotment spell is listed on table 1-1: Favored Soul. Deity's Weapon Focus: On the third level, the favored soul gets the Focus weapon's power with its deity's favored weapon. If the character already has this performance, he can choose another. Energy Resistance (Ex): At level 5th, the favored soul selects the energy type and gains a resistance of 10 against the flow. Bonus languages: Popular language options for souls include Celestial, Abyssal and Infernal (languages of good, chaotic evil and legal evil outsiders).
