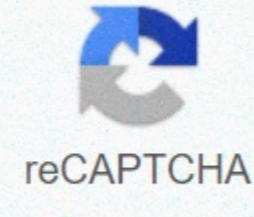

Veridian silver spring homicide

Rahul Gupta was convicted of first-degree murder in March in the stabbing death of Mark Waugh.Gupta portrayed his confession that he stabbed his best friend to death in a Silver Spring apartment after a celebratory drinking night and said his girlfriend was the aggressor. I loved him more than his own life, Reported Waugh's mother, Nancy, in court. Friends for years starting out at Langley School, the two apparently did. Gupta was studying to become a biomedical engineer; Waugh was at Georgetown University Law Center.During an October 2013 weekend, they gathered to celebrate Gupta's 24th birthday. Early the next morning, police found them both covered in blood in an apartment in Silver Spring.Along with friends, the couple had gone out to celebrate and ended up returning to the apartment to continue drinking, Said Gupta's girlfriend, Taylor Gould, to The Washington Post.As Kamala Harris becomes vice president, how did we grow the number of women and women of color in political roles? I found them cheating and killed my friend, he told the apartment detectives, according to The Washington Post's report on the opening judgment statements. Gupta, 25, of McLean, testified that Gould killed Waugh, 23, of Great Falls. He said he tried to stop the bleeding, gave Waugh chest compression and told Gould to call the police. The Post reports that Gupta could not explain how Gould could have taken so many blows against Waugh, or why he confessed. But during testimony at the March trial, Gould, who earned a biomedical engineering degree from George Washington University, said that after consuming at least six drinks, she was too drunk the night Waugh died to remember what happened. She denied harming Waugh. I had no reason to hurt anyone, she told the jury. According to the affidavit, Gupta called 911 and Gould. the police at the door. They both had blood. (CBSDC/AP) - Montgomery County police are investigating the murder of Eric Somuah, who was found in his Silver Spring apartment. Just before 5:00.m. Wednesday police said they were called to the 34-year-old man's home on the East-West Highway by family members who had been unable to speak to him for days. Editor's note: The following story contains graphic descriptions of murder. WASHINGTON — The crime scene was so horrific that at the trial, several jurors struggled with nausea. In sentencing Mauricio Morales-Caceres, 24, of Silver Spring, Maryland, prosecutors alerted the victim's family members to turn their heads as photos of the crime scene were shown to the judge. Montgomery County District Court Judge Mary Beth McCormick was stoic as she looked, but the gasps came from various areas of the courtroom as prosecutors detailed the magnitude of the brutality in the case. The photos showed how Oscar Navarro, 36, of Silver Spring was stabbed 89 times in his own home. As his hands were literally ripped from his attempts to defend himself from his attacker, who wielded a 15-inch knife. And in an action that would label the monster aggressor by the victim's family, the photos showed that Navarro's liver had been ripped from his body and placed on his chest. Navarro was discovered at his Silver Spring home by his future ex-wife and their 7-year-old daughter. In an emergency call presented as evidence, Navarro's ex-wife, who withdrew from the room where the body was found, told a 911 operator: I'm like 'Oscar, Oscar!' but he doesn't answer. I don't want to get close because I was with my daughter. Prosecutors Steve Chaikin and Douglas Wink told the judge that Morales-Cáceres committed committed crime as a way to climb within the ranks of MS-13, a gang that is also known as Mara-Salvatrucha. Chaikin and Wink said at the time of the murder, Morales-Cáceres got a tattoo —one that was reserved for

members of the MS-13 gang of a certain rank. Chaikin told the court he had rarely seen such a clear case of extreme violence and. Not only was Navarro's liver ripped from his body, but Chaikin told the court that Morales-Cáceres also tried to remove Navarro's scalp. Morales-Cáceres' lawyers defended a sentence that would allow his client the possibility of parole. Emily Beckman, one of the lawyers defending Morales-Cáceres, told the judge that her client, who had entered this country illegally, had been exposed to scenes of brutality in her native El Salvador. As a child, a relative attacked the entire family with a machete, and Morales-Cáceres was wounded in that attack. This did not influence the judge, who considered the crime entirely deserving of life imprisonment without the possibility of parole. You asked for this sentence. I didn't do it, McCormick added. The judge called the crime the worst of the worst. After the conviction of his brother's killer, Nelson Navarro told reporters that the loss of his brother was difficult for the family. (WTOP/Kate Ryan) Before delivering his sentence, the judge shook his head and then read Navarro's sixth-grade daughter's letter, which he had written: He was always kind and lovely to me. Citing the macabre nature of the murder, McCormick noted that on the day he was killed, Navarro let Morales-Cáceres into his home. Even more horrible: you knew him and knew him well, McCormick said. You knew him, ambushed him, mutilated him, tortured him. And for what? A tattoo? After the sentencing, Nelson Navarro, brother of the murder victim, told reporters: He was more than my brother; He was my friend. He was always there for me. Despite the difficulty, Nelson Navarro felt it was important to be present in court to ensure that no one else could be injured by Morales-Cáceres. He added: It won't bring Oscar back, but justice has been served. If you knew three people were killed in a house, would you buy it? Brian Betts wouldn't have bought his Silver Spring, Md., house if he'd known a man and his daughter were killed there. Betts, Shaw's popular principal at Garnet-Patterson Middle School, was found dead in an upstairs room of his home on April 15, 2010. He connected with the gunman who killed him, Alante Saunders, the day before through a social chat line. Saunders and two other teenagers went to Betts' home with the understanding that the door would be left unlocked, police said. They came in and Saunders went up the stairs. He pleaded guilty November and was sentenced to life imprisonment with all 40 years suspended. When Betts purchased the two-story colonial brick at 9337 Columbia Blvd. on July 2, 2003, it had already been the scene of a double homicide. On August 6, 2002, a 9-year-old girl was whipped and shot and shot at close range by a man who had broken into the house. Her father, Gregory Russell, was shot six times and also died. Betts didn't know the history of the house when he bought it, and tried to get out of business when he found out. He was sad, shocked, upset and did everything he could to rescind the purchase of this house, said Betts family attorney Rene Sandler. But he couldn't get out of it. In Maryland, real estate agents are not required to tell potential buyers if a murder had taken place there. Then Betts arranged for two ministers to bless the house to erase any persistent evil. Since his death, Betts' family has handed the house over to the bank. If the Betts family had made their way, they would have demolished this house, they would have made a memorial permanently to Brian K. Betts, Sandler said. Said.
