That figure represents an 11.6 per cent drop in the crime rate between 2016 and 2017. Compared with 2013 data, the five-year crime trend showed that the overall crime rate fell by 24.3%. In 2017, the King County Sheriff's Office recorded eight murders, 42 rapes, 100 robberies, 947 assaults, 1,105 burglaries, 1,822 larcenies, 777 motor vehicle thefts and 70 arson. The district has had more cases than other law enforcement agencies. Burien Police (PD) recorded 2,657 offences in the same year, while Carnation, Covington and Kenmore police reported 41, 848 and 400 offences respectively. Maple Valley, Newcastle, Sammamish, SeaTac, Shoreline and Woodinville police stations carried out 360, 267, 537, 1,862, 1,705 and 410 offences respectively. The Washington State Patrol WATCH program is the agency responsible for providing accident reports and background checks in King To find and obtain an accident report, use the state patrol collision report. The fee for each accident report is \$10.50.Criminal RecordsWassington State Law empowers sheriffs and police chiefs to collect data on sexual prosecutions and kidnappers and contribute them to the state registry. Sex offenders in this database include those classified in Tier II and III and non-compliant level I offenders. To access this database, visit the Search for Sexual Preinic page maintained by the King County Sheriff's Office. The public can search for names to search for individual sex offenders or kidnappers. Another option is the Zip Search feature useful for finding all offenders living in different parts of the district. The sheriff's office is also responsible for maintaining the inmates' file. It offers a convenient prison search service that will help the public find people who are booked in any of the district's adult and juvenile detention facilities. Just look for your last names. To refine the search results, specify your name, gender, race, and date of birth. Users can also limit their searches to people booked or released within the last 24 hours. Court records The King County District attorney's office keeps all the information on the District Control Court. These include non-confidential documents from civil, criminal, family laws, minors, custody and court cases. To view these records, start by searching for case numbers and dockets through the Record Access Portal. Use the information obtained to access case documents through the King County ECR web portal. Please note that applicants must register on the website and pay for the use of this service. The district clerk charges 25 cents per page for access to court records. ECR Online provides access only to cases that have been filed since 1 January 2004. The database does not include cases of juvenile crime and custody. The office charges \$25 per CD for duplicate audio recordings. The clerk also accepts requests for court records by post. Download, fill out and submit a request form to any of the three locations. Add Attn: Correspondence Desk to your mailing address. To request electronic delivery, include a self-addressed stamp envelope for a postal reply or email address. The clerk requires a \$10 deposit to process postal claims and will report additional costs if necessary. When ordering by post, fill in the application form together with a check or a cash order for a valid fee to the official statistical office. Make a check or payment order to pay vital statistics and add \$4 per payment processing order. Processing.
