Coaching We have recently been informed that several coaches of professional CS:GO teams have exploited a bug in the game to gain an advantage over their opponents. It's a shame and frustrating that we haven't responded to this bug before. But bugs are the reality of the software, and until they are fixed, we need to be able to trust players and coaches. We won't spend much time here underlining our position on the importance of integrity in CS:GO matches. At the very least, we expect players and coaches to play by the rules and immediately stop the game and notify tournament administrators if they know of an issue that could give them (or an opponent) an unfair advantage. All teams disqualified for exploiting this bug during an RMR event will have their MRI points restored. As for the action against individual coaches, we will wait to get a complete picture of the extent of bug abuse and punishments issued by third parties. Regardless of these penalties, the mid-game coach will always be an opportunity for some teams to violate the integrity of the game. So we could also consider limits to coaching.
