Somerville public schools reopening

When I read the many pages of our district's plans to return to school, I only had two questions: how do you take care that it can't be transmitted to anyone else? The plan did not respond to these questions. I do not believe that it

is possible to answer these questions, given the current testing situation in our country. If everyone could be tested every day and you needed a negative test to get into the school building, maybe. But the truth is, kids and teachers bring the virus to school, and no one knows it until someone gets sick enough to go to the test, and waits for their results, and the test turns out to be positive and no one finally reports from school. People with coronavirus can spread it before they start developing symptoms. Some people who have COVID-19 have a mild enough case that they will never realize that they are infected. In our current economy, if there is a risk of school and not working, if you have a positive COVID-19 test, I am sure some people suspect that they have a chronic virus, but avoid testing so they can continue to work or keep their children in school. Many, perhaps all, schools half ass reopening plans are defenseless against all of the above. What a plan to keep the virus out may seem like a contrast to the NBA bubble in Orlando. Schools need to open up in person to some parents to be able to work, and some students get the services they need. If we had spent the last four months that the community would be divided to a much lower level, as other countries have done, it would be a safe way to do a limited reopening. If we had tightened up our testing infrastructure, we would be able to realistically require students and staff to test negatively to get to school. But we So we're stuck in this mess. If team owners can't keep COVID-19 under control for the money-making season, what hope do we have when lives are at stake? Over two months ago, the doors to schools and colleges were closed and all learning was forced online. As the school year finally approaches, every state, school district and all colleges and universities are moving forward with plans for a safe reopening of education is linked to the reopening of the economy, but more importantly it is directly linked to the future of the country. But an effective reopening plan must give priority to the health and safety of students, academics and the entire country. If students cannot attend school safely, parents cannot return to work. While teachers tried hard to do online learning work, it's no substitute for in-person learning. Despite some success, it has been ineffective for too many students. It can't wait for autumn. Schools and colleges must make available summer learning opportunities to compensate for disruption and prepare students for future educational challenges. It's a cost, and the federal government has to step up and pay the bill. How to accommodate students when they show up is another big question. First, above all, the facilities are regularly wiped clean. It also means ensuring effective social distancing. Classrooms simply don't fit 100% occupancy of students and ensure social distancing. Some may suggest that half of students even attend weekdays, while others attend replacement days. Instead, the double sessions model many school districts embraced when schools were overcrowded in the 1950s should be adopted. I experienced this schedule when I attended PS 61 in New York City.
