Step 3 Certify Some states require pharmacy technicians to become Even in states where certification is not required, most employers will only hire pharmacy technology that are certified by the Pharmacy Technicians Certification Board (PTCB) or the National Association of Health Care Workers (NHA). PTCB requires applicants to pass an exam, while the NHA requires students to complete a training program or have at least one year of experience working as a technician. Both organizations require applicants to have a baccalaureate diploma. Step 4 Specialize Some pharmacy technicians choose to work exclusively for a retail pharmacy chain and will complete specialized training to serve as a general pharmacy technician, community pharmacy technician or central pharmacy operations technician, or in a similar role. Step 5 Maintain pharmacy technology certification must pass a recertification exam every two years. They must complete at least 20 hours of continuing education before sitting the recertification exam. Technician of Pharmacy Employment: The technicians of Basic Pharmacy work under the direction of a pharmacist with licence to dispense medicines and provide information to the clients. Pharmacy technicians usually work behind a pharmacy, grocery store, hospital, nursing home or other medical facilities. This position consists of working with pharmacists, patients and occasionally with pharmaceutical representatives. Basic working functions include dosing medications and filling prescription orders, caring for administrative tasks, and managing basic customer service functions at the counter. Some pharmacy technicians lead a team of pharmacy staff members as the lead pharmacy technician. Others may be responsible for managing supply and inventory or providing relevant information to other healthcare professionals. Becoming a pharmacy technician can be a gateway to a career as a pharmacist, nursing assistant or other medical professional. Demand for pharmacy technicians is expected to remain high over the next decade, which makes this career path potentially rewarding for those who want to work in a pharmacy environment. The average annual salary for pharmacy technicians in 2014 was \$29,810, though this varies by state. Pharmacy technicians in Washington, Alaska, California, Hawaii and Oregon are the highest earnings, on average. They typically include a combination of classroom learning and laboratory training for students to learn how to dispense medication, prepare sterile products, and manage prescription orders. Graduates of a one-year program can apply for entry-level positions in pharmacies, hospitals, nursing homes and assisted living facilities, or with pharmacy companies via email. Obtaining an associate degree can also help a student prepare for a pharmacy degree or a degree in a related field. In addition, they should have cultivated the following skills: Attention to detail The main responsibility of pharmacy technicians is to dispense prescription drugs, which requires great attention to detail. Pharmacy technicians should be able to measure, mix, dose and dispense adequate amounts of drugs based on the pharmacist's orders. They may also be involved with data entry tasks to update patient records and fill prescription orders. Pharmaceutical literacy Sometimes pharmacy technicians will have to read and interpret pharmaceutical literature and prescription information. They must have knowledge of pharmaceutical and medical terms and, in some cases, translate information for the benefit of the client. Exceptional customer service Although it is not the responsibility of pharmacy technicians to provide medical advice, they will be responsible for interacting with customers when dispensing medicines. They should have basic customer service skills to make sure they are providing customers with the right recipes, contact customers to advise them that the prescription is ready and monitor query that customers may have about their order. Pharmacy technicians in the organization can work on a variety of configurations. Some environments, such as retail pharmacies and grocery pharmacies, may be busier than others on a daily basis. Pharmacy technicians, therefore, should be able to handle different types of Work with great precision under pressure and keep everything organized behind the counter. Although pharmacy technology certification and undergraduate programs require practical training, some general courses can be completed online.
