To find out what's best, they need to know how these two costs compare and what options they have to keep costs down. The cost of private school, according to figures from the National Center for Education Statistics (NCES), about 4.5 million American children were enrolled in private schools between 2011 and 2012. More than 80% of these students were in schools with a kind of religious affiliation. Some 43% attended Catholic schools and another 37% attended schools identified as generally Christian, Jewish or a particular Christian denomination. Some 68% of all private schools have a religious. On average, the cost of private school tuition for the 2011-2012 school year was '10,740 per child, according to the NCES. This is a considerable burden for a common family.
