Example of a note: Say, explain, describe, and talk are usually used and will require the Boy Scouts to perform these actions during class. When these action verbs are part of any requirement, scouts are expected to be willing to share. Reading the answer is not acceptable because it does not meet the requirement to demonstrate the knowledge and understanding of the Boy Scouts. Explain what citizenship in a nation means and what it takes to be a good citizen of this country. Talk about the rights, duties, and obligations of a responsible and active American citizen. Visit the site, which is listed as a National Historical Landmark or is on the National Register of Historic Places. Tell your consultant what you learned about the sight or place and what you found interesting about it. Tour your state capitol building or the U.S. Capitol. Tell your counselor what you've learned about the capitol, its function, and its history. Tour the federal facility. Explain to your counselor what you saw there and what you learned about his function in the local community and how he serves this nation. Choose a national monument that interests you. Use books, brochures, the Internet (with parental permission) and other resources to learn more Monuments. Tell your counselor what you have learned and explain why the monument is important to the citizens of this country. Watch the national evening news five days in a row OR read the front page of a major daily newspaper five days in a row. Discuss national issues you have learned about with your adviser. Choose one of the problems and explain how it affects you and your family. Talk to your advisor about each of the following documents. Tell your counselor how you feel life in the U.S. can be different without each of them. Declaration of Independence Preamble constitution Amendments to the Constitution List of six functions of power as stated in the preamble to the Constitution. Talk to your counselor about how these functions affect your family and the local community. With the approval of your adviser, choose a speech of national historical importance. Learn more about the author and tell your counselor about the person who gave the speech. Explain the importance of the speech at the time it was given and say how it applies to American citizens today. Select a sentence or two from a speech that has a significant

meaning to you and tell your counselor why. Name three branches of our federal government and explain to your adviser their functions. Explain how citizens are involved in each branch. For each branch of government, explain the importance of the system of checks and balances. Name your two senators and a member of Congress from your congressional district. Write a letter on a national issue and send it to one of these elected officials, sharing your opinion with him or her. Show your letter and any response you get to your counselor. There are about 114 national monuments, but more like 90,000 historical sites. So any scout should be able to visit some historic site not too far, but the nearest national monument could be quite far away. My son started researching these points and saw some disturbing things... also, these are not his views. Regardless, from your description, it's my opinion that a counselor pushes his views instead of doing his job as a merit badge counselor. There is always another side to situations like this, but the demands ask the Boy Scouts to state their views, not parrot the views of their adviser. December 10, 2019 - Peg Thank you, Paul. Sorry, it's for Condition 8 - a letter to the senator giving ™ on the subject of national He began by writing several passages on the need for stricter gun controls. The adviser felt his stance would be strengthened by mentioning counterclibals, but those he wanted to include (such as the ones I mentioned) took him to strange websites with some gruesome details. After five revisions, he then claimed he ™ wrote it and wanted it to start over with another theme. It was funny. I think he's just ™ his position on gun control. My son ended this request with another counselor, but the whole experience certainly soothed his enthusiasm for scouts. That person, in my opinion, has nothing to be your counselor. I want to make sure no other child has to experience this kind of thing in the future. The #4 says that every document is discussed, not every item within each document. Scout should be familiar enough with each document to discuss its effect on the country. If the counselor requires the Boy Scouts to remember all the amendments, I'll find another counsel and tell the District or the president of the Progress Council about my concerns. For example, virtual visits to a city council meeting, national historical sites, museums and art galleries may be but swimming, firing a rifle and merit badges for motorboats cannot be completed virtually. The word may mean that at the discretion of the merit badge advisor if the consultant thinks a virtual visit would satisfy the intent of the request or not. Only my opinion, but I think in most cases the Scout will have a better experience if they wait until they are able to visit the National Historical Landmark or the National Register of Historical Places in person (many can be visited outdoors). On the other hand, if a scout is close to aging from the program, then maybe that's not an option for a Boy Scout.
