The county clerk can also administer oaths and make affidavits. The County Clerk: (1) collects wheel taxes, local hotel/motel taxes, wholesale beer tax, commercial license, and vehicle registration fees; (2) keep the official registers of the legislative body; (3) keeps a record of all resolutions submitted to the legislative body (both those issued and those that failed to pass). Not all plates can be processed online. The vehicle must be verified on the local county computer system. This may prevent some transactions from being processed. If you have a special license plate class that requires proof of enrollment, you can't renew online. Military renewal cannot be processed online due to the necessary documentation. Some email filters may prevent you from receiving the confirmation email. If you are entering the registrar's office to conduct business on BEHALF OF SOMEONE ELSE, please fill in and authenticate this Power of Attorney form. This will help you complete the transaction on the same day. If you move to Robertson County from another TN County, enter and update your address and pay the wheel fee. You will pay the wheel tax for the rest of the registration period. If you do not The moment you move to Robertson County, get ready to repay the wheel tax from the moment you moved to Robertson County until the renewal deadline, plus the renewal fee for the following year. If you purchased a vehicle from an Estate, provide a copy of the death certificate and proof that the person who signed as a seller had the authority to do so. When you pull a vehicle, you request a license plate or transfer a license plate from one vehicle to another. State law requires the applicant or owner to visit the county clerk's office. If you cannot personally negotiate this activity, a representative can be designated by an authenticated power of attorney. The Public Prosecutor's Office must identify the vehicle based on production, model and identification number. A form can be collected at the county chancellor's office or by clicking on the link above. If you purchased a vehicle from an out-of-county dealer, be sure to bring your new registration to the chancellor's office to pay the county wheel tax. It is NOT collected from other counties. Robertson County Wheel Tax is \$85.25. If you don't come to pay the wheel tax, be prepared to pay the rear wheel fee when renewing your registration. If your vehicle is new, bring all cards related to the purchase. This includes the manufacturer's declaration of origin, or MSO, the dealer's new car invoice, odometer statement, and loan practices if funded. If the vehicle was purchased by an individual, please present a correctly signed title with odometer reading placed in the appropriate line. If the vehicle is financed, bring the loan documents. The vehicle purchased by private individuals may request a gift form from the seller if the sale price does not agree with the guide to the value of the NADA vehicle. If you want to transfer your current tag, bring your current tag or registration. Transfers from immediate family members may qualify for a tax exemption. A gift form must be filled in. For joint buyers: Regardless of the conjunction, when a vehicle is purchased by more than 1 buyer, all the signatures of the parties are required on the title (or a Power of Attorney can be used). the committee on the use of work
