Child Support Information The Department of Children's Pensions Enforcement, in conjunction with the Florida State Payments Unit (SDU), serves as the central warehouse for receiving, recording, reporting, monitoring and distributing monetary residence payments and payments from M.Moon, in accordance with Florida law, Section 61.181. The Florida Legislature passed Chapter 98-397, Florida Laws (CS/CS/HB 271) which mandated a Department of Revenue contract with the Florida Association of BailHouse Officials (FACC) and each warehouse to perform duties with respect to the operation and maintenance of the State Disengagement Unit (SDU). With the passage of Florida laws, Section 61.1824, the Legislature established a central location for the collection and dismantling of child livelihood payments known as the Florida State Desalination Unit (FLSDU). The FLSDU will be responsible for collecting payments and dismantling payments for Brevard County. The Child Enforcement Department (CSE) assists resuscitated parents (whether married, separated, divorced or unmarried) with the location of unmarried parents. The CSE department assists in establishing paternity and/or a child support order, and enforcing child support obligations even if the non-breadwinner parent resides in a state other than Florida or resides in a foreign state. A voice response unit (VRU) is available with basic payment details. VRU will also allow you to speak to a customer service representative. If your support is paid through an income deduction order, your employer will be notified to send the payments to the FLSDU, but don't feel sorry to share this message with them. By this expanded application, the clerk is able to put more court records online and at public fingertips than ever before. While anonymous and registered users have access to a bunch of case information, access to protected cases is controlled by the Florida Supreme Court and identity verification for specific user roles is required. Users familiar with the firm's current search application, eFACTS, and our lawyer application, AttorneyView, will find BECA a more powerful search tool with enhanced image capabilities. BeCA's enhanced functionality will replace these two legacy applications, and will be waiting for a one-case search application for all clerk office users. As a result, both eFACTS and AttorneyView will be turned off at the close of business on Monday, January 8, 2018. Users are advised to register with beca to avoid any service disruption when these legacy applications are disabled. Access to eFACTS and AttorneyView will remain until January 8, but the clerk no longer accepts new users for AttorneyView.
