The Law provides for shorter deadlines for the completion of the bankruptcy process, allows greater flexibility in negotiating restructuring plans with the small commercial debtor and its creditors to facilitate the development of a consensual reorganization plan. The Coronavirus Assistance, Relief and Economic Security Act (CARES), signed by President Trump on March 27, 2020, has made a number of changes to bankruptcy laws designed to make the process more accessible to companies and individuals economically disadvantaged due to the COVID-19 epidemic. These include raising Chapter 11 Chapter 5 debt reduction to \$7,500,000, excluding federal emergency relief payments due to COVID-19 from current monthly income in Chapter 7. The changes apply to bankruptcies filed after the Medicare Act was enacted and set after one year, and, like Chapter 7, Chapter 11 requires the appointment of a trustee.
