VAT is a tax that you pay as a consumer when buying goods and services in the European Union (EU), including the United Kingdom. In the UK, the standard VAT rate is 20 per cent. Disabled people do not have to pay VAT when they buy equipment that has been designed exclusively for the disabled, or to adapt equipment so they can use it. In addition, VAT is not levied on certain services provided to disabled people, including some construction work on adapting a disabled person's home and renting equipment for the disabled, like wheelchairs. Goods and services that you do not have to pay VAT on are often referred to as zero assessment or right to VAT exemption. In other words, the VAT rate charged to them is zero. Rules on VAT benefits for disabled people does not have a zero VAT rating. Who is eligible for VAT exemption law states that you must be chronically ill or disabled to qualify for VAT exemption. A person is chronically ill or disabled if they are: There are physical or mental disorders that have a long-term and severe effect on their ability to carry out daily activities na condition that doctors treat as a chronic disease (e.g. diabetes, for example) or a terminally sicka person with temporary trauma, as a broken leg will not gualify, and will not be a fragile elderly person who was otherwise well and not disabled or personal or home use by a chronically ill or disabled person to gualify for a zero grade. Things not covered by this include: Products and services used for business purposesProducts are widely available for a group of people to use Products and Services provided to people who are or live in a hospital or nursing home as part of their medical or surgical treatment or with any form of careProducts that are eligible for VAT exemption Some examples of products that have zero VAT assessment are : WheelchairsSome medical and surgical techniques - like artificial limbs, for example, electrically or mechanically adjustable chair beds or ladder liftsComputer software or equipment designed specifically for disabledGadgets and devices that are designed solely to facilitate everyday tasks for the disabled, like kettle dump trucks vehicles that have been adapted for the use of disabled wheelchairs or stretcher userServices that are eligible for VAT : Maintenance, maintenance and installation equipment for disabled so that a disabled person can use their no-body building change in the house Disability vehicle qualificationmotor vehicles if you are a wheelchair or stretcher user, you do not have to pay VAT when you buy a car that has been substantially and permanently adapted for your personal personal Wheelchair users are defined as anyone who has to use a wheelchair - food or manual - in order to be mobile. Any adaptation work done on an unadapted vehicle to make it fit for a disabled person, regardless of whether the person is wheelchair user, is also entitled to a zero grade. Read the Motor Vehicles for Disabled Persons notice on the HMRC website (opens a new window) Equipment How to operate VAT benefits Before paying for any product or service, make sure it is eligible for a zero rating and that the provider is registered with VAT. When you buy a zero-rating product or service, you may have to sign a form that says that you have a chronic illness or disability and what it is. You must also state that the product or service at a price that excludes VAT. You don't have to pay VAT and then return it to the government - it will be withdrawn from the before you pay.
