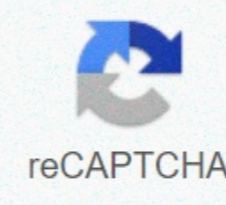

There is a two-year transition period and therefore the training arrangements for the 61st edition can continue to be used until 31 December 2022. Appendix I.1.5, as shown in the 61st edition, has been adopted in Subsection 1.5 and Subsection 1.5 of the 61st edition has been moved to Annex A to Appendix H. Guidance material on the development and implementation of competency-based training and evaluation can be found in Appendix H. This material is the practical guide for industry actors to develop their training framework in accordance with the new provisions and will continue to be improved by the Hazardous Goods Training Working Group (DGTWG) based on feedback from training providers and member airlines.
