Lawyers can rise to the top of the corporate ladder, holding an address as a senior law officer. These executives usually started out as in-house general counsel, treating legal matters related to the company's business, from regulations to financial issues. These executives earned an average annual pay of \$161,570 as of May 2011, according to the bureau. As for the the two most profitable industries for lawyers were the production of petroleum and coal products and natural gas pipelines, to the office. Lawyers specializing in these fuel energy industries earned two of the top five average wages in the bureau's May 2011 statistics. Those who earned an average of \$215,760 a year in crude oil and coal production, while those in the pipeline business earned \$182,300. Most people don't understand how important it is for spouses to have similar financial goals and habits, says Joslin Davis, vice president of the American Academy of Marriage Lawyers. Even if you decided to keep your actual bank accounts separate, you still have a financial partnership that comes into play. Financially, marriage creates one economic unit out of two, says Andrew Samalin, director of the Divorce Financial Planners Association. Anything contacted during the marriage (paychecks, interest on savings, pension funds, etc.) is considered a spousal fund and can be divided in the event of divorce. Usually, you can share your debts and income and share the risk and rewards of your investment accounts, he adds. Divorce takes a long time - and a lot of money. Weddings are known for their crazy price tags, but it also costs a fair amount to withdraw from these nusts. People expect to pay between \$300 and \$500 an hour, says Minion. There are a few [divorce] cases that can cost \$5,000 or \$15,000 if they're settled quickly. And there are also those that can be many multiples. Of course, each situation is different, but it can take up to a year or more for the divorce to be finalized. You're divorcing the person you married. Even after the divorce, you're going to be dealing with your ex for the rest of your life, and they're probably not going to change. Clients often come to me to amend the divorce decree telling me that their ex drinks around their kids or doesn't pay the bills that were ordered to pay, Daniel says. When I ask how their ex behaved during marriage, it's usually the same story: They drink too much, they don't pay their bills. After the divorce, they don't get any better. You won't automatically get everything if your spouse cheats. Wanting to buy a disloyal spouse with cleaning products would be normal - but you probably won't be able to. In most states, marital misconduct, like a case, does not entitle an innocent spouse to more assets, Davis. Money and wealth are divided according to the usual equitable distribution, so do not assume that divorce is an anti-fraud insurance policy. Your lawyer's not your therapist. You may not need to know this before you get married, but it's helpful to keep in mind when you start the divorce process. When they meet divorce lawyers, people often want to tell their stories, and that's a mistake. They want to explain why they're getting divorced and to enforce their reasons, Minion says. But the truth of what brings them to court is irrelevant to the end result. At this point, you'd be paying too much for lawyers to try to hash out what you did or what you feel in the office. The moral: See the counselor before you get to that point - and you have a better chance of avoiding it in the first place. If you're getting a divorce, you're going to have to check your ego at the door. Especially when it's kids, says Ben Heldfond, co-author of Our Happy Divorce with Nikki DeBartolo. Divorces go bad because they reach hard and fast with two of the biggest ego buttons there are: romance and finances, Heldfond says. You have to try to make all the decisions, especially those related to romance and finance, based on what's best for your kids and not on what's best for you. Adds DeBartolo: It's not fair to turn your kids into a huge emotional bill and expect them to pay off for the rest of their lives.
