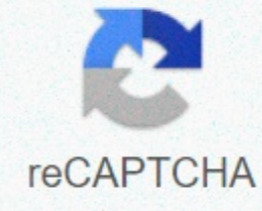

Sample letter to landlord for repairs

READ BEFORE USING THIS DOCUMENT*** The following document applies only to Kentucky jurisdictions that have enacted a unified landlord tenant. These jurisdictions are: Barbourville, Bellevue, Bromley, Covington, Dayton, Florence, Lexington-Fayette County, Georgetown, Louisville-Jefferson County, Ludlow, Melbourne, Newport, Oldham County, Pulaski County, Shelbyville, Silver Grove, Southgate, Taylor Mill and Woodlawn. If you don't live in one of these jurisdictions, don't trust this document for legal advice. In addition, this information only applies to housing leases. It shall not apply to: commercial entities, properties for sale, hotels or motels or people employed by the landlord. Here's an example letter you can send to your landlord if you plan to repair your property and deduct the cost of your rent. Read more about the landlord's maintenance obligations and how to wither repair rent. **You can also download this letter in Microsoft Word format.** Date Dear Landlord: According to KRS 383.595, the lessor is obligated to comply with the requirements of all applicable building and housing rules that materially affect health and safety and make all repairs and do everything necessary to get the premises in order and to keep them in habitable condition. Accept this as an announcement that I'm asking for the immediate repair of faults in my home. If you do not comply with this request within fourteen (14) days [twenty-four (24) hours, if there is an emergency] after receiving this letter, I can do the necessary work professionally and after making a statement to you about the work actually being done, I can then deduct the cost of my next month's rent. I understand that repair costs cannot exceed half a month's rent or \$100, whichever is greater. The defects in need of repair are: ____ I will make a request for correction in accordance with Section 383.635 of the County Or County Health or Housing Act. In addition, according to KRS 383.705, retaliation is prohibited and I understand that the landlord must not retaliate by increasing rent, reducing any services and/or evicting me. If a landlord tries to retaliate in one of the above ways because I request corrections or file a complaint with the Code Enforcement Agency, I may have the right to recover a maximum of three (3) months' rent, as well as a reasonable lawyer's fee. I believe that the repairs I have requested will contribute to the overall maintenance of the apartment and I recognise that this will benefit both parties. I want to stay a tenant in my home and cooperate with you in any way I can. I hope that we can reach an agreement on the corrections immediately. Sincerely, reviewed August 2009 Name Landlord Tenant Rent a house at the address and has been your tenant for the past five years. According to my lease, you are responsible for all repairs needed in the house. The taps are leaking. Double-fold doors are coming off the tracks. The locks are sticking. Things, as they say, happen. In general, it's not usually a big deal. If something goes wrong in your apartment, whether it's one of the above things or something else, the landlord or maintenance staff tend to be more than willing to solve the problem quickly. And if you have a good relationship with these people, even better. But regardless of whether you and your landlord

exchange gifts during the holidays, it's important to always put your maintenance requests in writing. The reason to write to beginners, landlords and property managers can be busy people! Writing a request makes their work easier — most of the time, there's a system in place to ensure that all such requests are quickly taken care of, either because of the severity of the problem or when received. Secondly (and most importantly), the official, dated communication serves as proof that you told staff about the problem and provides a timetable for monitoring the resolution or its shortcomings if necessary. Who to talk to In one of the apartment communities there are automated systems where maintenance requests can be made online, while others require maintenance requests in person at the office. Make sure you get the reference number and print a copy of the shipment (and if an automatic response is created, save it!). Request a photocopy signed for the latter as proof that the files have been sent. When the problem occurs, immediately call your designated contact (whether it's a landlord or management agency) to let them know about the problem, but immediately follow a written maintenance request to make sure your problems are dealt with quickly – and that you're protected in the process. Details are important. The necessary repairs must be described carefully. This ensures that the landlord, serviceman or technician is ready to take up the job. It's also important to remind your property manager of the required notice before entering (if you don't remember, this information should be in your rental agreement). Be polite and professional! Always be polite in communication with a landlord or property management company. Keep in the way that if requests are not answered, these letters and emails will serve as proof that you have followed the procedure reasonably and politely. Part of the compliment is patience. Most maintenance problems are solved within a very reasonable time. at least a couple of days to get to yours. If the problem is more serious (for example, it is the height of winter and your heat does not work), there are usually laws that regulate how much time the landlord has to answer. Sincerely, [Your name] Emergencies can't wait! If your problem is serious (a broken pipe floods your apartment), find an emergency service number in your rental agreement and call immediately. In fact, it is good to write it down and keep convenient if such a need ever arises. Comments Read this: Spain / Español Contents From this letter Download template letter (Word) It is important to put your repair or service requests in writing, even if you have already spoken to the landlord, manager or super. You can use the letter below as a guide. Download it and fill it with your personal information. Be sure to keep a copy of your letter and proof that you have posted it. You can prove it was mailed by sending it certified mail with a return receipt. Include the following information in your letter: A problem in your home. Last Review and Update: February 13, 2017 Landlords in almost all states have a legal responsibility to keep safe and secure in the rental unit and provide habitable spaces. These obligations are typically the result of either state or local housing rules or the landlord's general obligation to act appropriately. For example, landlords are generally expected to take steps to ensure that tenants are not at risk of harm from crime, environmental risks or problems caused by lack of maintenance, repairs or home improvements. Making sure the landlord is aware of the problem In some cases, landlords, especially absentees, may be unaware of problems with your rental unit or property, or at least may not understand the seriousness of the situation. Writing requests in writing – whether it's locks, radon testing, repairing an unstable staircase or railing, or better outdoor lighting – can be an effective way to get results. Written information about your complaints about personal safety issues – especially when the landlord has not kept promises – encourages your landlord to take action. In addition, if you plan to withhold the rent, you will need proof that you have given the landlord written notice of the problem. (For more information, see Rent withholding Activity.) And a written complaint or request letter is useful evidence if you end up suing your landlord. What to include in the letter to your landlord Your letter should remind the landlord of the foreseeable consequences of the landlord not addressing the obvious problem; propose a sensible solution; and suggest that the consequences, such as health problems, fire or burglary or assault, are serious. Also ask for the landlord's reply within a certain period of time (for example, five working days). Your letter doesn't necessarily have to threaten the consequences if your landlord isn't cooperative. It is better that there is a clear implication in the letter that you will take the request seriously and act in some as yet unspecified way if a favorable response from the landlord is not forthcoming. Use this model tenant letter, which warned the landlord about dangerous conditions as a model in preparing your own letter. If you are aware of events that have already occurred and are related to a specific security issue, be sure to mention it in your letter (as well as anything else that motivates the landlord to take action). Confirm your point by signing your letter from as many tenants as possible. Keep a copy of your details and your landlord's response information. Answer.
