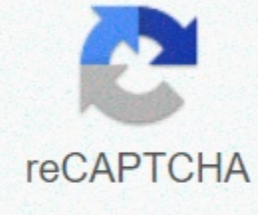

Writing a good set of by-laws is essential whether you are running a small business or a very large business. Decide in which state you want to officially build your small business; this doesn't need to be the country you're going to do most of your business in. Get the forms you need to set up your entity legally. Some states will require merger clauses. (It's different from in-laws and not covered here.) Check with the relevant state department to determine if you are required to file your in-laws with that state. Calculate the rights and responsibilities of shareholders in the first article. (The term article refers to a specific part of the law, often some numbered section dealing with a specific point in the article.) This will include where shareholder meetings are held; when annual meetings are held; and how special or extraordinary meetings can be called and how notices for special or exceptional meetings will be given. You may want to set guidelines for determining a shareholder record date. Finally, you need to define what sets the quorum of the meeting; who chairs the meeting; how voting takes place (including proxies); and how the meeting was postponed.
