You must accept a disclosure to access information from the database. Bail and bond manY a man from the Manitowoc County jail by taking bail to court. Typically, bail is a form of property that is 10% of the total money charged for an offense. It's set according to the court's bail schedule. The court will decide how much money to pay as a cost of the crime they have committed. If you are financially insolvent, you must obtain the services of a bail and bondman. A licensed bail and bondman would after the bail money on your behalf and charge a minimum of \$100 as their service fee. They are held in detention centers approved by Immigration Custody and Enforcement until their hearing or date they are deported back to their home countries. To find the detainee, users need the full legal name that the person used in their arrest and the country where the person came from. It also helps to type the A number, which is the number that ICE assigned to them on their detention, which you use instead of trying to type the name of the detainee. Name.
