The state of Texas categorizes offenses based on severity in Class A, B and C with the most serious crimes punishable by fines of up to \$4,000 and jail time of up to a year. Some examples of Texas state misdemeanors include the following: Class A: Burglary of a vehicle carrying a gun without a license Class B: Possession of up to two ounces of marijuana class C: Theft of property worth less than \$100 What are Texas Felonies? Texas state felonies are offenses that are considered the most serious crimes in the state. These offenses typically come with punishments, including jail time or jail time, and in Texas, they are categorized based on severity in 5 classes. Those categories include capital felonies, first-degree felonies, second-degree felonies, third-degree felonies, and state prison felonies. Capital felonies are Texas' most serious crimes by repeat offenders. They are punishable by life imprisonment with the possibility of parole if the offender is under the age of 18. Texas severe traffic violations refer to traffic-related offenses, which often include intentional disregard for public safety that result in property damage, serious injury and in some cases death. The state of Texas attributes ticket fines based on the county where the offender received a referral. In addition to this, the Texas Highway Patrol Division operates a point system that allows you to evaluate each driver's performance in the state. Each traffic violation is reflected on the offenders driving record as a point, and accumulated points on the offender's driving record attract penalties and fines depending on the severity of crimes. Texas Conviction records are official documents indicating that an indicted person was found guilty of a crime after a court hearing and/or their plea. Sentencing records typically include personal information about the convicted as well as information about the alleged crime, the punishment they have received, and other relevant information involved in the prosecution. The records may also include information about parole, fines and dishonorable discharges resulting from the conviction. Convictions are usually handed down by a jury of peers or a judge in a court, but most records exclude information about convictions that have been pardoned or reversed. Texas Jail and Inmate Records Texas prison and inmate records refer to official documents relating to the various residential facilities in the state of Texas as well as relevant information about persons housed in those facilities. The Texas Department of Corrections maintains information gathered from various homes that can be obtained by guerying the department or from searchable online inmate database. Texas probation records are official documents detailing the conditions under which a person can be allowed to serve their sentences outside a correctional facility. These records typically contain information about the indictment as well as personal data on the subject along with probationary conditions. The probation service is typically issued in relation to the crime, as such, the details can vary from case to case. Probation and supervision fall into five categories: pretrial supervision, felony conviction probation, misdemeanor conviction probation, felony deferred sentencing, and misdemeanor deferred settlement. What is Texas Juvenile Criminal Records? Texas juvenile criminal records refer to documents describing crimes committed by a person who is legally considered to be minors. Juveniles are not considered convicted after a trial. Rather, young people found guilty are considered convicted criminal. While most juvenile criminal records are confidential, they remain available to the public unless the subject successfully petitions for its delete as adults. However, after eliminating the site of human error, current technological advances have improved the quality and accuracy of registration improved exponentially.
